Summary of the key matters discussed at the Thirty-Sixth Annual General Meeting of Advanced Packaging Technology (M) Bhd held at Hotel Bangi-Putrajaya, Off Persiaran Bandar, 43650 Bandar Baru Bangi, Selangor Darul Ehsan on Thursday, 31 May 2018 at 12.30 p.m

Datuk Ismail bin Haji Ahmad ("the Chairman") presided as Chairman of the Thirty-Sixth Annual General Meeting ("36th AGM" or "the meeting"). The Chairman called the meeting to order at 12.30 p.m. after confirmation of the requisite quorum being present pursuant to Article 61 of the Company's Constitution. - 2. Approval of the payment of Directors' Fees of RM225,500 for the year ended 31 December 2017.
- 3. Approval of the payments of Directors' Benefit (excluding Directors' Fees) up to an amount of RM80,000 from 1 June 2018 until the next AGM of the Company.
- 4. Re-election of Mr Law Mong Yong as director who retired in accordance with Article 87 of the Company's Constitution.
- 5. Re-election of Dato' Haji Ghazali B. Mat Ariff as director who retired in accordance with Article 80 of the Company's Constitution.
- 6. Re-election of Datuk Ismail bin Haji Ahmad as director who retired in accordance with Article 80 of the Company's Constitution.
- 7. Re-appointment Messrs PKF as Auditors of the Company and to authorise the Directors to fix their remuneration.
- 8. Retention of Dato' Haji Ghazali B. Mat Ariff as Independent Non-Executive Director in accordance with the Malaysian Code on Corporate Governance 2017.
- 9. Retention of Mr Mah Siew Seng as Independent Non-Executive Director in accordance with the Malaysian Code on Corporate Governance 2017.
- 10. Retention of Mr Ng Choo Tim as Independent Non-Executive Director in accordance with the Malaysian Code on Corporate Governance 2017.
- 11. Approval of renewal of Shareholders' Mandate for the Company to buy-back its own shares.

There being no other matters to be transacted, the meeting was called to a close by the Chairman at 1.15 p.m. with a vote of thanks accorded to the Chair.
